5. PUBLIC HEARING

- a. Public Hearing to consider Conditional Use Permit application No. PC 18-06 submitted by Mr. Kintu Patel of PMB Group, LLC, to conduct Commercial Cannabis Cultivation, Manufacturing, Distribution, Dispensary and Retail Delivery activities and to perform a Site Plan Review to allow for the construction of a new 28,144 square-foot building on a parcel within the M (Manufacturing) zone with a General Plan land use designation of Industrial. The property address is 3580 Fruitland Avenue (APN 6311-017-044). This item was remanded from the City Council on October 10, 2018.

Public Hearing to consider Conditional Use Permit application No. PC18-13 submitted by Mr. Mike Iniguez to allow for the sale of beer and wine for on-site consumption in conjunction with a dine-in restaurant (Cevichez & Michez) on a parcel located within the CM (Commercial Manufacturing) zone with a General Plan designation of Mixed Use. The property address is 4944 Slauson Avenue (APN 6314-028-026).

Recommendation: Conduct the Public Hearing; thereafter, waive further reading and adopt the resolution to approve CUP PC18-13.
